4.1 Resolution No ETSB 24-07-110

Amended schedule of the Council of Commissioners meeting

WHEREAS the *By-law No. 1 – Meetings of the Council of Commissioners* paragraph 1 states that "Regular Council of Commissioners (the Council) meetings will be held on the Fourth Tuesday of each month of the school year at 7:00 p.m. and at the Eastern Townships School Board (ETSB) Administrative Building situated at 340, Saint-Jean-Bosco Street, Magog. (CQLR 162)";

WHEREAS the *By-law No.* 1 – *Meetings of the Council of Commissioners* paragraph 2 states "The ETSB's Secretary General shall draft the schedule of the meetings to be adopted by resolution before June 30th and to be published in accordance with requirements for public notice";
